

# Peter Max Returns to Beachwood

Peter Max first visited Beachwood for the opening of the City of Beachwood's municipal complex in 2007 and will proudly be welcomed back as the City of Beachwood's centennial celebration continues.


**A** newly-curated collection of Peter Max's exquisite paintings will be on exhibition and available for acquisition at the Beachwood Community Center, Saturday, Oct. 16 through Sunday, Oct. 25.

Max, an iconic American artist who is known for his cosmic landscapes and figures and vibrant art, has curated an exhibit that spans his 50-year career – from pop art to his Masters series, in which he interprets the works of Van Gogh, Monet, Picasso and Renoir in his own signature style and colors.

Max has had the distinct honor of painting the portraits of the last seven presidents of the United States and the world's best loved celebrities, among them the young sensation, Taylor Swift. His works are displayed in museums, presidential libraries, U.S. embassies across the globe, and thousands of galleries worldwide. He has been the official artist of the Grammys, five NFL Super Bowls, the 2006 Olympics, the World Cup USA, The World Series, The U.S. Open, The Indy 500, The NYC Marathon and The Kentucky Derby. He was also the official artist of the 30th annual induction ceremony for the Rock and Roll Hall of Fame, held right here in Cleveland.

When talking with him on a phone interview, Max told us he can recall his love for painting from a very young age while living in China. His mother, Salla, a fashion designer, cultivated his talent by leaving art supplies on the balconies of their pagoda home. She'd say, "Choose any balcony and medium, make a big mess and we'll clean up after you."

His art interests continued to grow, and while living in Haifa, Israel, Max took art classes and was introduced to the works of Henri Matisse, Maurice Vlaminck, Max Beckmann and Alexi Jawlensky.

With an interest in astronomy, Max became absorbed in learning about the vastness and wonders of the universe and began to study art and astronomy simultaneously, which is reflected in his art of "The Cosmic '60s."

Max then lived in Paris where he took classes at the Louvre.

When he moved to New York at age 17, Max began his formal studies at the Art Students League in Manhattan under the tutelage of Frank Reilly, a realistic painter. Reilly's classmate, turned out to be one of America's favorite artists – Norman Rockwell. The League is still an institution of which Max speaks highly.


While studying, Max had an intense desire to master realism and he spent hours perfecting the skill. During his spare time, he frequented museums to study techniques of the masters.

When Max saw the print

industry expand to a four-color web press, he knew he could reproduce his art as posters, which opened a new world of possibilities. Soon, Max's posters were hanging in college dorms all across America, with several million sold in nine months. His posters were to the '60s what MTV was to the early '80s – radical, revolutionary and in demand.

To the youth of America, the '60s was the great American renaissance. The Beatles sang about it in songs like *Lucy in the Skies*; the musical, *Hair* was brought to the Broadway stage; and Max, with his signature style, captured its creative spirit. "Pop art was in," Max told us. "It was a reflection of the times and a reflection of what I learned in art school."

Like the Beatles, Max made his TV debut on the Ed Sullivan Show. He also appeared on the Tonight Show with Johnny



Carson and made the cover of *Life Magazine* with an eight-page feature cover story.

Max's art was so much in sync with the times that it was licensed by 72 corporations, from General Electric clocks to Burlington Mills socks.


Today, Max says he built a nice surrounding with about 65 people to meet the demands of his artwork and products. Nonetheless, he is still inspired each time he picks up his brush. When asked about his process, he said, "I don't know what I'm going to create until the paint hits the canvas." When asked about future aspirations, he said, "I'm going to keep on going to create the funniest, greatest most unusual stuff in the world."

His favorite painting?

"Every painting is my favorite. It's exciting because every week there's something new. Every time I finish a painting, I say, 'oh my god, wow!'"

“They need to draw and paint a lot to find their own style,” Max said, and then added, “It’s important to be encouraged by parents and art teachers.”

Peter Max’s exhibit will fea-

ture his iconic and best-known pieces, including Statue of Liberty, Max’s famous Flag pieces, Umbrella Man and the prestigious Cosmic Runner. There will also be presentations of his celebrity portraiture, for which Peter Max is revered.

A Preview Party will take place on Friday, Oct. 16, from 7-9 pm. The gallery opens Saturday, Oct. 17.

Peter Max has created a commemorative piece, titled Beech Trees, which he will gift to the City of Beachwood. This will be presented in a special ceremony on Saturday, Oct. 24 at 5:30 pm. Mayor Merle S. Gorden and the Beachwood City Council will be in attendance.

Two meet-the-artist recep-

tions take place on Saturday, Oct. 24, from 6-9 pm and Sunday, Oct. 25 from 1-4 pm.

Gallery Hours are Monday-Friday from 10 am to 6 pm, Saturday from 10 am to 9 pm, and Sunday from noon to 5 pm.





# Couple Shares Dirt on Path to Top Tough Mudder Ranking

Love can lurk in unlikely places, but would a Tough Mudder event, involving a 10-12 mile course featuring obstacles with names like Arctic Enema, Electroshock Therapy, Ladder to Hell, Kiss of Mud, Birth Canal, Balls to the Wall and Cry Baby be one of those spots?

For Beachwood residents Devon Musko and Andrew Blakley, both 27 years old, the answer is most assuredly yes. Their mutual love for each other and the grueling outdoor, military-style endurance events reached a climax in August with a marriage proposal in New York where they had traveled for more muddy Mudder mayhem.

But first, the intensity of their attraction to Tough Mudder should be qualified. It has catapulted them to the top of the heap, with Devon ranking #1 among women for competing in the greatest number of events in the world and ranking #2 among all participants with 78 completed. Andrew ranks #2 in the world for men and #3 overall, right behind Devon, with 72 completed. Their involvement began in 2012, and since then, they've been attending events held nationwide every weekend on Saturdays and Sundays during the March through October season.

What they've accomplished is

remarkably monumental, but to meet them is to discover two very balanced, casual and serene, but frequently self-deprecating, people. Of course, they are ultra-tough – 20–25 spleen-splitting obstacles litter the courses — but that just scratches the surface. Plenty of the grit required to finish an event lies in their minds as much as it does in their muscles.

Actually, the courses are designed intentionally to test physical as well as mental strength, playing on common fears of fire, water and heights, not to mention pain. But the courses are also meant to inspire teamwork, with participants almost uniformly committed to helping others complete the challenges. The object is simply to finish – it's not a race – and no one cares how long that takes. On average, 78% of the participants reach the end.

But what if you become injured? "You just go slower," says Devon, matter-of-factly. "And you stick with friends who are injured, too." She once tore some calf muscles. That was a long day.

Eventually, their bodies do say no to the weekly schedule.

"But we feed off each other and get amped up," says Andrew.

"We keep saying we're going to cut back, but we never do," says Devon.

By the end of the course, they are generally covered from head to toe with mud. "I'll need to wash my hair a few times to get it clean," Devon notes.

"I'll still have gravel in my hair after a shower," Andrew claims.

So why do they do it? And how did it become essentially a lifestyle?

Andrew blames his competitive nature. Plus, he wanted to become more athletic. And soon the events became gathering places where he developed friendships with people from around the country.

"I get excited to see everyone

every time. So I don't think much about why I do this, I simply love being there."

Devon explains that she turned to Tough Mudders to help her lose weight and get into shape.

"I was fat, but I lost 30 pounds in the first year I attended the events. I felt competitive with myself. I really wanted to improve."

Both she and Andrew are also conscious of eating well by balancing proteins, carbs and fats, and drinking about 100 ounces of water per day. Devon is strict with her calories, consuming about 1,200 per day. Andrew is disciplined with his gym attendance, showing up two to three times each week for strength work. But they admit to having weight fluctuations of about 20 pounds during the off season, which also overlaps with the holidays.

In her first event, she reports failing every obstacle and taking six-and-a-half hours to finish the course. Though she admits that she's not the most athletic or strong person, she does own being committed and having endurance. "While it isn't always pretty, I get it done."

Another source of motivation is the contrast between her sedentary job, working indoors all week as the branch employment coordinator at IGS Energy (where Andrew also works in sales), and the vivacity of the outdoors. "I love getting outside, playing in nature and being physical."

Neither can ignore the sense of accomplishment derived from Tough Mudders either.

"It's something that seems absolutely impossible, so it becomes very emotional," says Devon. Andrew also draws on the thrill of assisting others. "I know nothing about these people, but suddenly, I feel like their best friend when I help get them through an obstacle."



Andrew's favorite obstacle is Everest, a quarter-pipe challenge that instills fear in many since it's terribly difficult to scale. That's why he likes to help pull people up. "I've seen grown men cry with happiness at reaching the top."

Devon is partial to Funk Monkey 2.0 due to its level of challenge. It involves climbing monkey bars upward, then across a horizontal set, then back down more monkey bars, requiring tremendous upper body strength and coordination. She feels incredibly proud at its completion.

There is unanimous dislike between them for the Electroshock Therapy obstacle where participants run through a field of 1,000 live dangling wires, totaling 10,000 volts of electricity. Bales of hay and sink holes add to the torture. It's considered the great equalizer since strength and conditioning play no role. It's the final obstacle – with a cup of beer awaiting them after the finish line. Devon was knocked out by it in her second Mudder event, but she's not unique. People drop to the ground all the time from shocks. Not to be entirely short-circuited by the experience, they decided to limit their involvement with this obstacle to every 10th Mudder.

In addition to her unparalleled standing in the Tough Mudder circuit, Devon has earned a sponsorship arrangement and spokesperson status with MET-Rx (a nutritional supplement brand, with the slogan "You Can't Fake Strong"). She's featured on the company's website in a candid video profile where she details her Tough Mudder journey at <https://www.metrx.com/team-legit-strong/devon-musko>.

Devon is keen to share that Tough Mudders attract every body type, and not one in particular will prevail.

"I thought I needed to be ripped to be considered in good shape and especially to be able to do this, but I don't think that anymore." Her evidence: a participant who is very lean and posts his diet and training

workouts online proved to be no competition for Devon. "I beat him at the world competition."

"I'm not an athlete, but I do have mental strength," she adds.

"She kills it out there," notes Andrew.

The world event takes Tough Mudder to an extreme level of extreme. It's held over a 24-hour period, and the male and female competitors who complete the greatest number of laps around the five-mile course are the winners, each garnering a \$10,000 prize. One team of competitors is awarded \$12,000.

The couple will compete for the third time in the world competition in November in Henderson, near Las Vegas, where temperatures can plunge into the twenties at night. For the required swimming, wet suits are necessary. So is a little reckless abandon. Hills and obstacles are all part of the ordeal for which they use the weekly Mudder events to train. Last time out, Devon covered 50 miles, plus 10 of penalties which were off course. At the world event a year earlier, Andrew endured a plantar fascia tear at mile 50 and was unable to run for a month and a half afterward.

Never mind setbacks. To intensify the weekly Mudders, both have made it their practice to often complete two laps around the course. Or they might attend the events on both days over the weekend. Also, Andrew frequently carries Bruce, a 100-pound dummy that gains 20 pounds from dips in mud and water, across his shoulders throughout the whole course. The dummy is inspired by the Wounded Warrior Project, serving as a way to honor a fallen, injured or overseas soldier, most notably, one who would have wanted to attend the Tough Mudder event.

"It's a powerful image. People are moved by it," Andrews says.

Devon has carried a 30-pound log in memory of a college friend who was killed in a car accident. He had been losing weight and successfully getting into shape. She thinks of him often, and his memo-

ry compels her to keep going.

The only rule they impose on themselves is limiting the events they attend to no more than a 10-hour driving radius from Beachwood. They depart shortly after work on Fridays, sometimes arriving just an hour before the event begins. Sightseeing and hanging out with friends after they run the course is another weekend highlight.

Being avid attendees, they both buy \$500 season passes each year, greatly reducing the \$100-\$200 cost of each event. Another way to lower costs is to volunteer at an event, while still participating, but with a delayed start.

Participants earn headbands every time they complete at an event, but at 25-, 50-, 75- and 100-event intervals, special bands are distributed. Devon and Andrew choose not to wear the ones they've earned.

"Sixty events sounds absurd!" says Devon. But that's not the only reason.

"We don't want to diminish others' accomplishments – just getting through the course, especially if it's their first one, is significant."

They never intended to make this their lifestyle, and Devon certainly never planned to get a husband out of it, either, but a fateful meeting through a Facebook Mudder page, and the subsequent events they attended together, all added up to this terrific romance and a great many good times.

The proposal came after an appropriate sequence of events. They stayed in Brooklyn the day before a

Mudder event on Long Island and rented Citi Bikes to tour the town. This included a stop at the Tough Mudder headquarters in Brooklyn where they were warmly greeted.

The ring was safely hidden in a pack Andrew carried with him all day, and after catching a subway into the city and having dinner with friends, they headed to the pier underneath the Brooklyn Bridge, which offers a spectacular view of the skyline. While sitting on a bench there, Andrew proposed.

Devon was so surprised and shocked that she can barely remember the details but she said yes instantly. Then she quickly implored him not to drop the ring in the water since they were so close to the edge of the pier.

Now a new obstacle course for the couple has emerged from the Mudder mud: a marriage...with love leading the way.

# BHS Student Combines Sports with Cancer Fundraising

Griffin Davis, a BHS junior who plays on the soccer team and is a kicker for the football team, scores in multiple ways every time he puts points on the board. He's running a campaign to raise money for childhood cancer research, and every pledge-per-point or straight donation helps him to attain his goal of raising \$1,000.

He is connected with the organization called Kick It for Cancer, an offshoot of the locally-based Flashes of Hope charity. He discovered Kick It this past summer at a soccer camp hosted at John Carroll University. He signed up to participate, and once he learned through the organization's email how pediatric cancer research is severely underfunded, he agreed to kick

off his own fundraising efforts.

"I can help save lives. Why wouldn't I do it?" he states.

He says he witnessed cancer in his own family – all his grandparents – so he knows the toll it takes. Griffin is the son of Stacey and Todd Davis.


"I feel a responsibility to help. Plus, I feel lucky that I don't have cancer."

He has received support from friends, coaches, teachers and relatives, and his campaign will be ongoing, but the points portion will end with the completion of his soccer and football seasons.

## MIDDLE SCHOOL: What to Expect ...

# Council Update

## SUMMER FLOODS ACTION PLAN

This summer our region experienced record setting rainfalls. Beachwood responded to 193 sewer back up calls in June and July. 103 were found to have issues (broken pipes, tree roots, clogs) on the homeowners' side.

While the majority of calls came from the northwest section of the City, there was not one specific street which had an overwhelming number of sewer back-ups. This is likely due to the preventative maintenance by our Service Department in conjunction with the County on our 300 miles of sewers. The County Sanitary Engineer confirmed every catch basin and every sewer (storm and sanitary) in this area was cleaned and flushed in 2014.

There were, however, three primary areas where sections of streets (not homeowners) experienced flooding. Our Service Department has been working with the Cuyahoga County Sanitary Engineer to address and develop an action plan. They are:

**SHAKER BOULEVARD NEAR I-271** Further investigation uncovered that a concrete drainage channel in the median had developed significant blockages due to silt, vegetation and debris. This blockage is being cleared with the help of the County and the Ohio Department of Transportation. Beachwood Service Department will also be asking Pepper Pike to have their outlet channel cleaned as well, so we are covered across neighborhood borders.

**GREEN ROAD BETWEEN EAST CARROLL BOULEVARD AND FAIRMOUNT BOULEVARD** Three sewers in this area will be videotaped as will the house laterals of the residents who submitted complaints. Upon completion, Beachwood will receive a report from the County.

**GLENHILL ROAD EAST OF LYNDRWAY ROAD** an analysis of the 54-inch storm sewer that runs through the side yards of Glenhill and Cedar Road residents is underway. In the interim, our Service Department has asked the City of Lyndhurst to clean a connected culvert outlet.

Thank you for your patience as we resolve these matters.







Diane and I have been Beachwood residents for 32 years, and our children, Carrie, Joshua and Gillian, all graduated from BHS. I am currently a partner in the law firm of Porter Wright specializing in corporate and securities law. I've served on the Boards of WVIZ/WCPN Ideastream, North Coast Angel Fund, Bnai Jeshurun Congregation, and the local chapters of Jewish National Fund and Ort America. **I am running for Council to leverage my experience in financial oversights and controls**, honed as a board member and corporate attorney, which are essential in today's changing and demanding environment.

Beachwood is blessed with strong community services that we must protect. The city's forefathers envisioned a balanced residential and commercial area providing a strong tax base. However, in the midst of the economic downturn, the city raised its

income tax rate, thus discouraging some businesses from moving here. The city's salaries and expenditures are among the highest in Ohio. Council has done an insufficient job of fiscal oversight and control. Only recent public exposure has led to salary and expense restraints. **One of my priorities is to review expenditures to ensure the city is obtaining the very best value and being efficient with our funds.**

**We can also do better by involving residents in community decisions and having an open, transparent government.** Legislative proposals should be available on-line before council meetings, as should copies of enacted legislation and policies. An interactive forum should be created for important matters, such as commercial expansion and new governmental buildings.

Recognizing past successes, the city must plan for a changing future. The city is more

diverse and older. It needs to be aggressive in attracting younger residents with families. **Beachwood should provide economic incentives to residents purchasing vacant and distressed properties.** Such properties diminish the value of adjacent properties; converting them into flourishing new family homes would benefit our neighborhoods. ## Budish and the Literacy Cooperative Join for International Literacy Day

**More than 400,000 adults in Cuyahoga County are at or below a seventh-grade comprehension level**

Cuyahoga County Executive Armond Budish and the Literacy Cooperative joined today in honor of International Literacy Day to discuss challenges and opportunities that exist in Cuyahoga County for more than 400,000 adults with low literacy, and have difficulty reading a prescription or completing a job application. The featured speaker was Jeff Conyers, executive director of The Dollywood Foundation whose featured program is Imagination Library.

Nearly 125 people gathered to hear from literacy advocates concerning the challenges faced by many in our community who are not able to read or write adequately or do simple math problems, as well as some of the programs and resources in the community to address these difficulties.

"Low literacy and a lack of workforce skills are a barrier to progress on social priorities that exist in our region," said County Executive Budish. "Reducing poverty, promoting public health, and helping people find better jobs remain at the forefront of this administration and we are committed to finding solutions that connect our most vulnerable citizens to the skills they need to succeed."

International Literacy Day is a world-wide awareness campaign founded fifty years ago by UNESCO (United Nations Educational, Scientific and Cultural Organization) to highlight the importance of literacy to individuals, communities and societies. Improving literacy leads directly to advancing economies, health and social equality.

The Dollywood Foundation and Imagination Library have achieved dramatic results. In the twenty years since its founding by Dolly Parton, Imagination Library has mailed sixty million high-quality, age-appropriate books to children in more than 1600 local communities, and 750,000 children are now receiving a new book each and every month. Statistics and independent reports have shown Dolly Parton's Imagination Library drastically improves early childhood literacy for children enrolled in the program. Conyers is hoping to establish a Dolly Parton Imagination Library program in Greater Cleveland.

## 3-D Mammography now Offered at University Hospitals Ahuja Medical Center

There's not much that is as anxiety-provoking as waiting to hear the results of a mammogram – let alone getting a false positive.

Tomosynthesis, also known as 3-D mammography, has been called one of the “hottest” clinical procedures by medical imaging specialists, because it reduces some of that anxiety due to its high level of accuracy. It has been available at University Hospitals Ahuja Medical Center since fall 2014.

Tomosynthesis is being lauded by clinicians for good reason. By taking images of the breast from multiple angles, the technology improves radiologists' ability to detect breast cancers by helping pinpoint the size, shape and location of abnormalities. This helps radiologists distinguish harmless structures from tumors, leading to fewer false positives. That means fewer call-backs and less anxiety for women.

University Hospitals was the first health care provider in Northern Ohio to offer tomosynthesis. Jill Dietz, MD, breast surgeon at UH Ahuja Medical Center and an oncologist with UH's Seidman Cancer Center, explains it this way: “Because tomosynthesis offers a view of the entire breast, it provides a better ability to pick up subtle changes in the breast. Think of it like reading all of the pages in a book instead of just the front and back covers.”

Notably, the technology has reduced the number of unnecessary call-backs by 15 percent.

Breast cancer experts now believe that tomosynthesis will soon become the “gold standard” in breast center screening and detection. “Tomosynthesis offers women the next generation in breast cancer detection,” says Dr. Dietz. “The technology is an important new tool in our arsenal

to detect breast cancer early when it is treatable.”
